

# Information on voluntary-test of novel coronavirus PCR test for the purpose of shortening the quarantine period after entering Japan

Reservation - only. Please make a reservation by phone in advance.

\* 0 4 3 8 ( 7 2 ) 9 9 1 6 (Internal medicine)

PCR test to receive measures for shortening the waiting period of 7 days at home etc. to 4 days (minimum)



This clinic is registered as the certified novel coronavirus test organization accredited by the Ministry of Health, Labor and Welfare.

**Target persons :** Those who are asymptomatic, are not close contacts and correspond to any of the following

① or ② after the third day after entering Japan

① Those who have a valid vaccination certificate with a red departure country / region

② Those who have not a valid vaccination certificate with a yellow departure country / region



Those who correspond to the places surrounded by  in Table 1.

**Available schedule (reservation and test) :** From Monday to Friday (included national holiday)

**Test method :** PCR test [Isothermal nucleic acid amplification ; NEAR (Nicking Enzyme Amplification Reaction)]

**Sample test :** Nasopharyngeal swab

**Time to find out the test result after setting the sample in the test device :** Around 13 minutes

**Inspection fee :** 9,500 JPY tax included

**Certification issuance fee :** 2,000 JPY tax included

**What to bring :** Original passport



## Flow of the day

- ① Please come to the laboratory behind our clinic at the reserved time and press the bell in the laboratory.
- ② Please show your passport. The receptionist will make a copy of your passport and measure your body temperature.
- ③ Please read the notes and fill in the necessary information on the questionnaire.
- ④ We collect nasopharyngeal swab.
- ⑤ The test result will be explained by the doctor on the day.

**\* The test result certificate will be issued on the same day (as a general rule, it will be given 30 minutes to 1 hour after the sample collected) .**

**[We may consult with you regarding the date and time of issuing the test result certificate for groups.]**



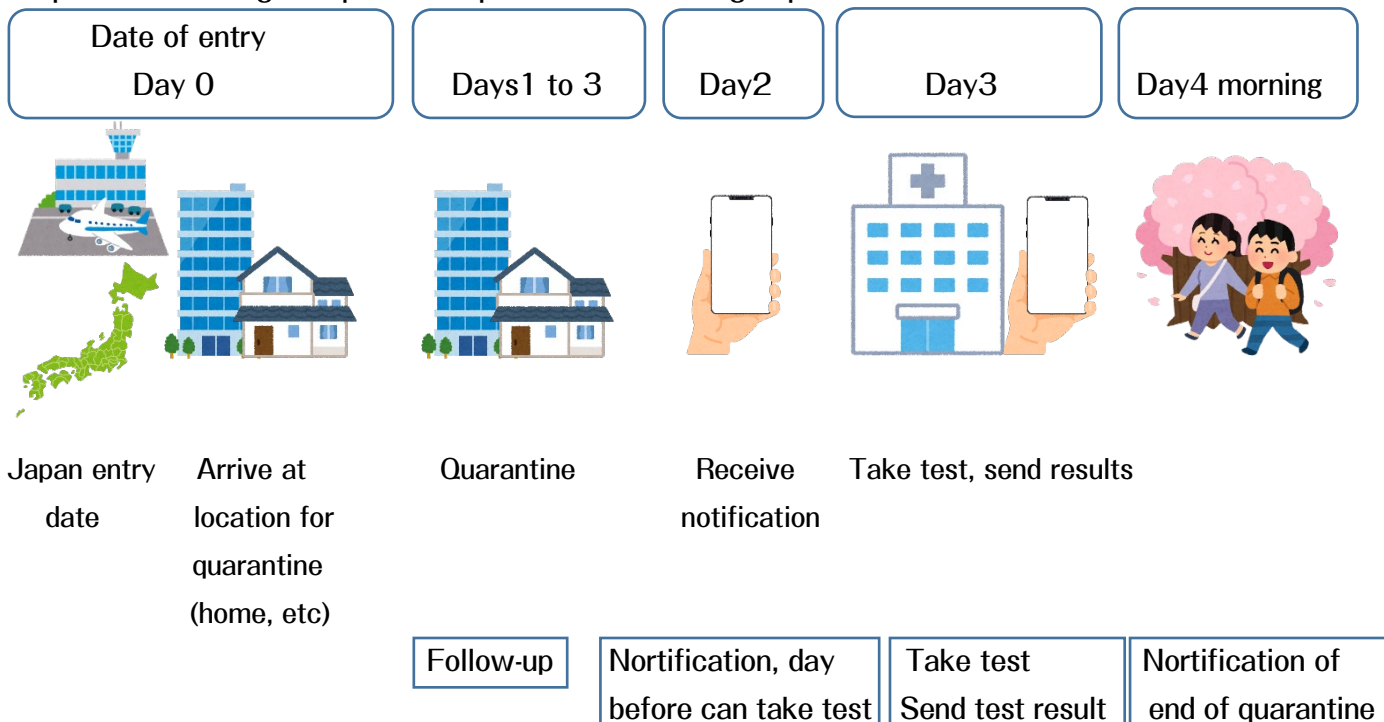
In order to shorten the waiting period at the shortest, the inspection that was voluntarily taken on the 3rd day after entering Japan during the waiting period at home etc. for 7 days after entering Japan.

It is necessary to report the negative result of (PCR test) from "MySOS App" to "Ministry of Health, Labor and Welfare (Immigration Health Confirmation Center)".



"Notification of the end of waiting" from the center eliminates the need to wait after the 4th day at the earliest. (Public transportation can be used after proof of no requirement of waiting.).
